Option to Purchase

If at the end of the agreed hiring period or any time during this period The Hirer purchases the instrument, there will be a credit allowed for hiring charges as follows:

*All hiring charges will be deducted off the retail value of the instrument.

***There is a limit of 2 three month hire periods**

Hirer's Obligation

1. Punctually to pay all hiring charges as set out above.
2. To keep the instrument hired in the same condition as when hired.
3. To protect the instrument hired against loss or damage.
4. Not to permit any person to use the instrument hired unless qualified to do so.
5. To permit The Owners to inspect the instrument hired on reasonable notice.
6. If the instrument hired shall at any time require repair to return the same to The Owners and not attempt any repairs himself. To do so renders The Hirer liable for full price of the instrument hired.
7. To notify The Owners of any change of address and upon request to inform The Owners promptly of the whereabouts of the instrument hired.
8. Not to part with the possession of the instrument hired and not to pledge the same.
9. To return the instrument hired in good condition at the end of the term of hire and to pay the additional hire rate per day in respect of any late return of the instrument.
10. The Hirer indemnifies The Owners in respect to its liability for personal injuries, property damage and any associated legal expenses arising out of any accident which might be caused by the instrument during the term of the hire.
11. To use the instrument hired in a skillful and proper manner and only for the purpose for which it was designed.
12. The Hirer is responsible for all charges and costs involved in removal from and return to The Owners premises at the above address.
13. Upon breach by The Hirer of any of the terms contained in this Agreement, The Owners shall be at liberty without previous notice to determine this Agreement and recover possession of the hired instrument.
14. The Hirer, or his insurers, shall be liable to pay for the cost of reinstatement or repair to the instrument in the case of loss (by theft, fire or through any cause whatsoever) and in the case of damage in circumstances where The Owners are of the opinion that the damage is caused by:
 - (a) Using the instrument for purposes for which it was not designed.
 - (b) Attempting to repair the instrument without the prior consent of The Owner.
 - (c) Negligence by The Hirer and/or his servants or agents.
 - (d) Accidental use of the instrument.
